**THIS AMENDMENT** (this “**Amendment**”) is made as of the date of the last signature, by and between **The Service Companies Inc.** (“Supplier”) and **THE REGENTS OF THE UNIVERSITY OF CALIFORNIA** on behalf of its Davis campus’ Student Housing and Dining Services, (“UC”).

**WHEREAS**, Supplier and UC are parties to an RFP awarded agreement from September 20, 2018 through August 31, 2021 (the “**Agreement**”); and

**WHEREAS**, Supplier and UC agree to add Appendix H- Qualified Individual Form; and

**WHEREAS**, Supplier and UC agree to extend the term of this agreement through February 28, 2022.

**NOW, THEREFORE**, it is hereby agreed that, as of the date set forth below, the Agreement is hereby amended as follows:

**1. Appendix H- Qualified Individual Form**

Appendix H- Qualified Individual Form, is attached to this agreement. The “Qualified Individual Form” shall be posted in a prominent and accessible place (such as break rooms and lunch rooms) where it may be easily seen by workers who perform Covered Services. In addition, UC Davis Employee Labor Relations will request quarterly reporting on the total hours worked by each of your employees at UC Davis.

**2. Term of Agreement/Termination**

The term of this agreement will be extended through February 28, 2022.

**3. Miscellaneous.**

Each party represents and warrants to the other that it has the authority to enter into and perform under this Amendment; and that the execution and performance under this Amendment will not violate any agreements with, or right of, any third party. This Amendment may be amended or modified only by a writing signed by each of the parties. Except as may be expressly set forth herein, all terms and conditions of the Agreement shall remain in full force and effect. As used in this Amendment, capitalized terms defined in the Agreement and not otherwise defined in this Amendment, shall have the respective meanings assigned thereto in the Agreement.

## Conversion from Contract to UC Employee Qualified Individual Form/Application

## Service Unit (SX) Contract – Appendix H

A contract worker will be deemed a qualified individual (QI) for conversion to UC employment when the worker has worked for a contractor performing the same services at the same UC location (i.e. at the same Campus, Medical Center, Lab or other location) for 1,000 hours over a rolling 12-month period, or 35% time over a rolling 36-month period.
