

## Simple Feast Theft Incident

Hi Team,

Today I was on site to install timeclock tablet for client Simple Feast which is located inside Amped Kitchens @ 230 W. Avenue 26 Los Angeles CA, 90031. Upon my arrival I began speaking with client contact Jacob and asking for feedback on staff as well as confirming install location for timeclock. I began setting up my equipment to install timeclock at which time client contact Pushp entered the kitchen stating there was a very urgent matter I needed to be aware of and to come with him right away which meant dropping what I was doing in the moment. We began walking down the hallway and he stated there was footage of an employee stealing and he was speaking with Paolo (head contact with us @ Simple Feast) as well as Amped Kitchen building manager. we then entered the Amped Kitchen office where Paolo and 2 Amped Kitchen managers were watching TVs on a wall. At this time, we are now all viewing the screen of 2 security camera feeds from yesterday between 1240pm and 1pm, one view is of the shared locker room and one view is an outside view pointed away from the building. The locker room camera was showing an employee near camera side going from a locker on the Simple Feast grouping of lockers and another locker on the far side of camera view, going from bottom screen to top screen multiple times. They stated it was EE Chase Adrain, and based on the body type and uniform being worn I concluded it to be Chase as well, he was wearing black and white checker chef pants, black chef coat and black chef skull cap and COVID mask. The lockers in the bottom of the screen were for Simple Feast only and you see him lock and unlock that locker but is freely opening the locker with no lock on it at the top of the screen. He is seen rummaging in the locker in the top of the screen appearing to go through a bag or purse and pulls out something resembling a key and lanyard as well as cash and other unidentifiable items. During one back and forth he is seen with cash and comes back to his locker and seemingly mixes in cash from the other locker into his own cash in his wallet, organizing and counting before placing back into his locker and locking. At one point he was talking to our other employee Kevin Wade but Kevin came in, put something in his own locker and leaves the locker room right after. Once Kevin leaves Chase is seen leaving the locker room and then is seen on the outside camera view walking in the street toward a car across the street. Once very close to the cars he appears to hesitate and stop as there was an Amped employee walking from outside back towards the entrance of the warehouse. Once the Amped employee is out of view Chase can be seen entering a vehicle from the passenger side and driving away. About 10 minutes pass and you then see Chase enter the locker room again and enter the unlocked locker appearing to further rummage at which time another employee from an unknown location enters startling Chase so he pauses and notices the other person is not paying attention to him so he acts as if he closing the locker and pushing in the bag/purse strap allowing the locker to finally close and leaves either at that moment or shortly after. During my talks with Jacob he did mention his phone was taken and that our employee Chase was very late to return from lunch yesterday and told him he had to walk to McDonalds so that's why he was arriving tardy.
