FUTURE SYMPTOMS AND CONDITIONS:

IMPORTANT: It is not necessary to report symptoms such as diarrhea, nausea, or vomiting if they are not associated with a fever.

• Chronic (CHRONIC). It is not necessary to report symptoms, such as diarrhea, associated with chronic medical conditions or illnesses.
